監管局舉辦比賽提升從業員書寫能力

EAA launches competitions to enhance writing skills of estate agents

地產代理監管局將舉辦「全港地產代理徵文 比賽」和「全港地產代理中文書法比賽」, 藉此提高從業員對持續專業進修計劃的參 與。

另外,監管局將為每位持牌人提供每年300元 的進修津貼,藉此參加特定的持續專業進修 計劃活動。持續專業進修計劃的評核費和周 年覆核費亦已調低,減幅約一成。監管局委 託香港學術評審局為監管局評核持續專業進 修活動,而評審局由2007年5月起調整其收 費。同時,監管局增加了評審局可評核的活 動模式,新增的活動種類包括多次性活動和 網上活動。 The Estate Agents Authority (EAA) will launch a writing competition and a Chinese calligraphy competition for the estate agency trade. The competitions are designed to raise awareness of the Continuing Professional Development (CPD) Scheme.

Separately, to encourage participation in the Scheme, EAA will provide each licensee with an annual CPD training subsidy of \$300 to offset designated CPD activity fees. Besides, the assessment and re-assessment fees for the CPD activities have been reduced by about 10 per cent. The Hong Kong Council for Academic Accreditation (HKCAA), which has been appointed by EAA to approve CPD activities, has revised its fee schedule with effect from May 2007. EAA has also expanded the type of activities that can be approved by HKCAA to include multi-session and web-based activities.





監管局專業發展委員會主席曾煥平先生表示:「監管局舉辦徵文比賽,目的是提高地產代理從業的語文水平及寫作技巧、鼓勵從業員分享經驗並擴闊視野。監管局亦同時舉辦中文書法比賽,希望通過另一種備受推崇的藝術形式,推廣『持續進修、敬業樂業』精神。」

持牌人的參賽作品如符合徵文比賽規則及條件,而監管局亦認為有關作品文筆流暢及修辭恰當,該持牌人將可取得3個持續專業進修學分(核心)。持牌人的參賽作品如符合中文書法比賽規則及條件,該持牌人將可取得2個持續專業進修學分(非核心)。

Chairman of the EAA Professional Development Committee Mr Joseph Tsang said, "The writing competition is to enhance the language and writing skills of practitioners by giving them a forum in which to share their experiences. The Chinese calligraphy competition will promote the spirit of 'Professional Excellence through Learning' through a highly-regarded art form."

Licensees who submit entries that fulfil the requirements of the writing competition rules and conditions and are considered eloquent and fluent by EAA will be awarded three core CPD points per entry. Licensees who submit entries and fulfil the requirements of the Chinese calligraphy competition rules and conditions will be awarded two non-core CPD points per entry.
