Estate Agents Authority reviews Qualifying Examination to promote agents' standards

(5 October 2004) The last paper-based Estate Agents and Salespersons Qualifying Examinations in 2004 will be held on Thursday, 4th November.

Chief Executive Officer of the Estate Agents Authority (the Authority), Ms Sandy Chan Pui-shan, pointed out that "in order to provide greater protection to public interest, the Authority will seek to enhance the standard of newly qualified estate agents. One of our core tasks in the future is to review the existing Qualifying Examinations for those who wish to join the profession. Specifically, we will consider introducing greater depth to the examinations with a view to upgrading the overall standards of the new recruits."

Ms Chan anticipated that the results of the review will be implemented in the Qualifying Examinations to be held next year.

Ms Chan added, "on the other hand, the Authority will be implementing the Continuing Professional Development Scheme early next year to encourage licensees to advance with the time and commit themselves to self-enrichment through lifelong learning."

The Authority's figures show that the number of registrants for the Estate Agents and Salespersons Qualifying Examinations this year has increased considerably compared to those of last year. In 2003, a total of 3,305 candidates registered for the Estate Agents and Salespersons Qualifying Examinations. In the first three quarters of this year, the number of registrants has reached 5,758.

Those interested in taking the Qualifying Examination should note that the passing of a Qualifying Examination is only one of the requirements for obtaining the licence.
