Media Liaison

The Authority continued to host briefings and press conferences to release relevant information through the media. During the year, the Authority made 126 responses to media enquiries, supplying information on legal and practical issues related to estate agency.

The EAA Resource Centre

The EAA Resource Centre provides information on estate agency and property transactions to licensees and the general public. Publications of the Authority, books and journals on legal subjects related to estate agency, and other relevant reference materials are available. The Centre also holds a collection of training videos and recordings of seminars and talks organised by the Authority.



Web Site and Official Newsletter

The Authority constantly updated its web site to release information widely and effectively. The site has been a convenient means for licensees and citizens to access latest information on licensing, regulatory affairs, practice, professional development and complaints.

During the year, the Authority published two issues of *Horizons*, the official newsletter on the activities of the Authority. The Authority also released two CD-ROMs on the *Rating and Valuation Department Account Enquiry Number*.
