## The EAA Launches New Consumer Education Videos and Roving Exhibitions

(5 March 2015) In order to protect the rights of consumers and promote related information in property transactions to the public, the Estate Agents Authority ("EAA") will launch two new consumer education videos. The EAA has always attached great importance to promoting consumer education in a bid to enhance the consumers' understanding of the services that could be expected of estate agents when appointing them. Following the videos on the subject of "land search" and "permitted use" of properties launched last year, the EAA has recently produced two new videos namely "Appoint licensed estate agent to avoid disputes" and "Fill in all the blanks in the provisional agreement for sale and purchase before signing to avoid loss". Related leaflets will also be produced to remind consumers not to appoint unlicensed estate agents and not to sign the provisional agreement for sale and purchase with important terms left blank during property transactions.
