

**Publication of list of individuals and entities under the United Nations Sanctions (Yemen) Regulation 2019 on CEDB's website**

On 9 November 2021 (New York Time), the Security Council Committee established pursuant to resolution 2140 concerning Yemen **added three individuals** to its sanction list. Please refer to the [press release](#) for detail. [Remarks: The concerned press release was only published on 11 Nov (HK Time)].

Pursuant to section 30 and 31 of the United Nations Sanctions (Yemen) Regulation 2019 (Cap.537CI), an updated list of individuals and entities is published on CEDB's [website](#) at 11:00 am on 11 November 2021. Sections 2 and 3 of the Yemen Regulation prohibit the supply, sale, transfer and carriage of prohibited goods (i.e. arms or related materiel) to individuals and entities on the list as well as those acting on behalf of or acting at the direction of such individuals and entities. Section 4 of the Yemen Regulation prohibits the provision of any assistance related to military activities or the provision, maintenance or use of any arms or related materiel to individuals and entities on the list as well as those acting on behalf of or acting at the direction of such individuals and entities. Section 5 of the Yemen Regulation prohibits the making available of any economic assets to or for the benefit of individuals and entities on the list, or dealing with any economic assets belonging to, or owned or controlled by such individuals and entities.
