

## **Publication of list of individuals and entities under the United Nations Sanctions (Haiti) Regulation**

On **8 December 2023 (New York Time)**, the Committee of the United Nations Security Council (“UNSC”) established pursuant to UNSC Resolution 2653 (2023) concerning Haiti **added four individuals** to its sanctions list. Please refer to the [press releases](#) for details.

Pursuant to section 26 and 27 of the United Nations Sanctions (Haiti) Regulation (Cap.537CO) (“the Regulation”), an updated list of individuals and entities is published on CEDB's [website](#) at **11:00 a.m. on 9 December 2023**. Section 3 and 4 of the Regulation prohibit the supply, sale, transfer or carriage of arms or related materiel to, or for the benefit of, certain persons or entities. Section 5 of the Regulation prohibits the provision of technical assistance, training or financial or other assistance related to military activities, or related to the provision, maintenance or use of arms or related material, to, or for the benefit of, certain persons or entities, while section 6 of the Regulation prohibits any person from making available to, or for the benefit of, certain persons or entities any funds or other financial assets or economic resources belonging to, or owned or controlled by, certain persons or entities.
