

## **Publication of list of individuals and entities under the United Nations Sanctions (Haiti) Regulation on CEDB's website**

On 21 October 2022 (New York Time), the United Nations Security Council ("UNSC") adopted Resolution 2653 in respect of Haiti. According to paragraph 18 of the Resolution, the UNSC decided that **one individual** listed in the annex of this resolution shall be subject to the measures imposed by paragraph 6 and 11 (viz. asset freeze and targeted arms embargo) of resolution 2653 (2022). Please refer to the [Resolution 2653](#) for details. No separate press release on this was issued by UNSC in respect of the above sanction list up to this moment.

Pursuant to section 26 and 27 of the United Nations Sanctions (Haiti) Regulation (Cap.537CO) (“the Haiti Regulation”), which was gazette on 3 March 2023, an updated list of individuals and entities is published on CEDB's [website](#) at 00:00 hours on 3 March 2023. Sections 3 and 4 of the Haiti Regulation prohibit the supply, sale, transfer or carriage of arms or related materiel to, or for the benefit of, certain persons or entities. Section 5 of the Haiti Regulation prohibits the provision of technical assistance, training or financial or other assistance related to military activities, or related to the provision, maintenance or use of arms or related material, to, or for the benefit of, certain persons or entities, while section 6 of the Haiti Regulation prohibits any person from making available to, or for the benefit of, certain persons or entities any funds or other financial assets or economic resources belonging to, or owned or controlled by, certain persons or entities.
