Prescribed Sources for Restrictions on Leasing

The Hong Kong Housing Authority and the Hong Kong Housing Society are the prescribed sources for Restrictions on Leasing under Item 5 of Part B of the Leasing Information Form (Form 2). Practitioners should have the updated lists of properties with restrictions on leasing available for the purpose of completing Form 2. Such lists may be obtained as follows:

Hong Kong Housing Authority

The Hong Kong Housing Authority's hotline is 2712 8000. Practitioners may dial the hotline and then enter 1-4-7-6 to receive by facsimile the list of estates under the Home Ownership Scheme and the Private Sector Participation Scheme with restrictions on leasing. The said list is also available on the Housing Authority's website (http://www.info.gov.hk/hd) and is at Schedule 1.

Hong Kong Housing Society

Practitioners may dial the Hong Kong Housing Society's hotline at 2882 1717 and then enter 1-4-3-4 to receive by facsimile the list of estates under the Flat for Sale Scheme, or enter 1-5-2-9 to receive the list of estates under the Sandwich Class Housing Scheme. The updated lists of the said schemes are at Schedule 2.

This Circular should be made available for the information of all staff engaged in estate agency work.

Notes:

- 1. Since the relaxation of restrictions on alienation on 2nd July, 1999, FFSS flats are subject to 5-year restriction. During the restriction period, owners have to first offer the flats to the Housing Society (HS) and, if the HS does not exercise its option to buy back within 28 days, owners can sell in the open market after payment of premium. From the 3rd to the 5th year, there is an alternative channel to sell in the Secondary Market at negotiated price without payment. Only certain category of applicants (e.g., public housing tenants) are allowed to purchase in the Secondary Market. Both purchasers and flat owners have to obtain the relevant certificates from the HS before they could enter into binding agreements for sale and purchase.
- 2. After the 5-year period has expired, owners can sell in the open market after payment of premium without first offering to the HS.
- 3. SCHS flats are subject to 5-year resale restriction. During the restriction period, owners have to first offer the flats to the HS and, if the HS does not exercise its option to buy back within 28 days, owners can sell in the open market after payment of premium.
- 4. After the 5-year period has expired, owners can sell in the open market after payment of premium, without first offering to the HS.
