Lists of Estates under the Housing Authority and the Housing Society

According to the Practice Regulation, practitioners are required to complete the Leasing Information Form (Form 2) when acting in respect of a residential property for leasing. Item 5 of Section B of the Form is on leasing restrictions. Estates under the Home Ownership Scheme ("HOS") and the Private Sector Participation Scheme ("PSPS") of the Hong Kong Housing Authority are subject to alienation restrictions. It is a contravention of the Housing Ordinance for the owner of a flat under the scheme to lease out the flat unless a period of 5 years from first alienation has expired and premium has been paid. Estates under the Flat for Sale Scheme ("FFSS") and the Sandwich Class Housing Scheme ("SCHS") of the Hong Kong Housing Society carry similar alienation restrictions. Practitioners should take note of the lists of the aforesaid estates as updated from time to time.

Housing Authority

The Housing Authority's hotline is 2712 8000. Practitioners may dial the hotline and then enter 1-4-7-6 to receive by facsimile the list of HOS/PSPS estates which have reached 5 years and the list of HOS/PSPS estates which have reached 2 years but not 5 years. The updated lists are also available on the Housing Authority's website (http://www.info.gov.hk/hd). They are appended as Schedule 1 to this Circular.

Housing Society

Practitioners may dial the Housing Society's hotline at 2882 1717 and then enter 1-4-3-4 to receive by facsimile the list of estates under the FFSS, or enter 1-5-2-9 to receive the list of estates under the SCHS. The updated lists of these schemes are at Schedule 2.

Notes:

- 1. FFSS flats are subject to 5-year resale restriction. During the restriction period, owners have to first offer the flats to the Housing Society (HS) and, if the HS does not exercise its option to buy back within 28 days, owners may sell in the open market after payment of premium. From the 3rd to the 5th year, there is an alternative channel to sell in the Secondary Market at negotiated price without payment of premium. Only certain category of applicants (e.g., public housing tenants) are allowed to purchase in the Secondary Market.
- 2. After the 5-year period has expired, owners may sell in the open market after payment of premium without first offering to the HS.
- 3. SCHS flats are subject to 5-year resale restriction. During the restriction period, owners have to first offer the flats to the HS and, if the HS does not exercise its option to buy back within 28 days, owners may sell in the open market after payment of premium.
- 4. After the 5-year period has expired, owners may sell in the open market after payment of premium, without first offering to the HS.
