The Estate Agents Ordinance (EAO) (Cap. 511) provides that a person shall not be eligible to be granted or hold or continue to hold a licence unless he fulfills all licensing requirements, and one of which is the Estate Agents Authority (EAA) otherwise considers him a fit and proper person to hold a licence. In considering whether an individual is a fit and proper person to hold an estate agent's licence (individual) or a salesperson's licence, the EAA shall have regard to, among other things, the fact that the individual is an undischarged bankrupt or has made an individual voluntary arrangement with his creditors (IVA) within the past five years. As you are an undischarged bankrupt / have made an IVA within the past five years, the EAA needs to consider your fitness and properness to be granted, to hold or continue to hold a licence.
